- 1. Reason for Guaranty. I/We make this Guaranty to induce Landlord to rent the Dwelling to Tenant. I/We know that, in the absence of this Guaranty, Landlord will not rent the Dwelling to Tenant.
- 2. Guaranty of Performance. I/we guarantee the faithful performance of all the terms, covenants and conditions of the Lease Agreement, as they apply to Tenant, and guarantee payment in full of all sums that may become due and owing Landlord by Tenant. This Guaranty shall remain in effect throughout the term of the Lease Agreement and any continuation or renewal thereof and so long as Tenant may owe any sum to Landlord. The liability of Guarantors shall be continuing, absolute and unconditional and Landlord shall not be required to exercise remedies against Tenant before proceeding against Guarantors. Landlord shall notify the Guarantors if Tenant shall breach the Lease Agreement.

- 3. **Performance.** If the Tenant defaults under the Lease Agreement, Landlord may require me to perform without first demanding that the Tenant perform.
- 4. Waiver of Jury Trial. I/we give up my/our right to a trial by jury in any matter involving this Guaranty.
- 5. Military Service. This guaranty shall remain effective, notwithstanding Tenant's entry into or involvement in military service or the provisions of the Servicemembers' Civil Relief Act or similar law.
- 6. Application. Guarantor confirms that the information on the attached Guarantor Application is trues and correct to the best of his/her knowledge.
